

healthy meal each day at our afterschool program which helps them to complete homework more successfully."



The Eyeglasses for Education program funded by United Way of Muskingum, Perry, and Morgan Counties was able to provide Ben with a new pair of glasses. He is now able to complete his lab tasks well and has more confidence to work hard.



John came to Catholic Social Services (CSS) due to difficulty managing his financial situation. He retired from a municipal job and received a large sum of money from his deferred comp account. The local attorney assigned to his case stated that she was concerned that he would mismanage this large sum of money or be taken advantage of by others. She wanted CSS to become his payee in order to manage his everyday financial needs but also ensure funds would go for his best interests. The CSS caseworker established a workable budget that pays his bills and meets his essential living needs while also allowing some of his wants to be achieved. One such "want" was to purchase a newer truck which he did recently after months of saving. Thanks to the funding provided by United Way of Muskingum, Perry, and Morgan Counties, today John is out of debt and has found peace of mind knowing that his finances are managed appropriately.

When Victoria began working at The Sweet Life Baking Co. as a trainee in the Recovery with Purpose program, funded by United Way of Muskingum, Perry, and Morgan Counties (MPM), she had only been clean from drugs for about 8 months. She had little job experience as she was a housewife for 12 years before being widowed at 31 and starting a new life at 35. The combination of training, support, and an understanding that she has received at The Sweet Life through the Recovery with Purpose program has enabled her to grow and thrive in each area of her life. Emotionally, physically, and financially- and of course, the continued gift of watching others grow.


goals, mending relations, leading house meetings, and regaining visitations and a healthy relationship with her children.
